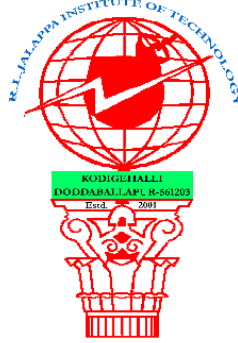

Policy for chemical waste management

Purpose:

The purpose of this policy is to establish guidelines and procedures for the proper disposal of waste chemicals produced within our Institution. This waste includes materials such as liquids, gases, or solids that are explosive, flammable, corrosive, toxic, radioactive, or infectious.

- a. Institute is responsible for coordinating and implementing the chemical waste disposal program. They will ensure compliance with all relevant environmental regulations and standards.
- b. Staff and Faculty: All staff and faculty members are responsible for identifying and reporting chemical waste within the campus.
- c. Students: Students are encouraged to report any chemical waste they come across on campus.

Chemical waste Collection and Storage:

- a) Designated Collection Areas: The Institute shall establish designated collection areas on campus where chemical waste can be deposited. These areas will be clearly marked and accessible to all members of the college community.
- b) Secure Storage: Collected chemical waste will be stored securely by the Institute in a designated storage area to prevent unauthorized access and theft.

Chemical waste Disposal:

The chemical waste disposal methods as followed in the Institute by Chemical treatment such as neutralization, precipitation, ion exchange, reduction, or oxidation.

Awareness and Education:





