# **IT Policy for E-Waste Disposal**

# **Purpose:**

The purpose of this IT policy is to establish guidelines and procedures for the proper disposal of electronic waste (e-waste) within our Engineering College. E-waste includes outdated or non-functional electronic equipment, such as computers, laptops, printers, and other electronic devices.

# **Responsibilities:**

a) IT Department: The IT department shall be responsible for coordinating and implementing the e-waste disposal program. They will ensure compliance with all relevant environmental regulations and standards.

b) Staff and Faculty: All staff and faculty members are responsible for identifying and reporting e-waste within their respective departments.

C) Students: Students are encouraged to report any e-waste they come across on campus.

## **E-Waste Collection and Storage:**

a) Designated Collection Areas: The IT department shall establish designated collection areas on campus where e-waste can be deposited. These areas will be clearly marked and accessible to all members of the college community.

b) Secure Storage: Collected e-waste will be stored securely by the IT department in a designated storage area to prevent unauthorized access and theft.

#### **E-Waste Disposal:**

a) Responsible Recycling: The IT department will ensure that all collected e-waste is disposed of through responsible recycling methods. They will engage with certified e-waste recycling vendors who adhere to environmentally friendly practices.

b) Data Destruction: Prior to disposal, all electronic devices will undergo a thorough data wiping process to ensure the complete removal of sensitive and confidential information.

c) We have an MoU with JSA web solutions, Bangalore for the disposal of e- waste from time to time.

### **Awareness and Education:**

a) Training Programs: The IT department will organize regular training programs and awareness campaigns to educate staff, faculty, and students about the importance of proper e-waste disposal and its impact on the environment.

b) Information Sharing: The IT department will provide information and guidelines on ewaste disposal through the college's website and other communication channels.

## **Compliance and Monitoring:**

The IT department will monitor and review the implementation of this policy regularly to ensure compliance. Non-compliance with the policy may result in disciplinary actions.

By adhering to this IT policy for e-waste disposal, our Engineering College aims to contribute to environmental sustainability and promote responsible electronic waste management practices.
